16-26 June 2011. Sara Fregonese was in Beirut conducting fieldwork for her British Academy small grant project “Views from the Holiday Inn: War, Landscape, and Memory in Beirut”. Sara conducted extensive archive research, photography and ethnography in the Minet el Hosn neighbourhood around the former Holiday Inn hotel, a once cosmopolitan area, gradually made part of civil war frontlines in the mid-1970s and since then living besides the post-war development process of the Lebanese capital. The project investigates the role of hotels as urban geopolitical sites and aims to produce an archive of the memory of Beirut’s former Holiday Inn.
