Fernando's thesis is entitled 'Café culture and urban conviviality: cosmopolitanism, public culture and contemplation in Madrid'. Fernando will be taking up a twelve-month ESRC Post-Doctoral Fellowship in the Department in the new year, on the theme 'Café culture: creating convivial cities'.
