

# Royal Holloway, University of London Course specification for a postgraduate award MSc Mathematics for Applications (1282)

### Section 1 - Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. The course is delivered over one year of full-time study (52 weeks). The course is also available part time; you would normally complete the programme within 2 years (104 weeks) but College regulations permit up to five years of part-time study (260 weeks). It provides in-depth training and research experience entirely at Masters level. You receive training in generic scientific and discipline-specific research skills.

Royal Holloway is internationally regarded as a centre of excellence in mathematics and applications (particularly in cryptography and information security). The MSc is taught by members of the Mathematics Department and the Information Security Group and students have the opportunity to be supervised by researchers covering a wide range of research topics.

This course requires a minimum of 6 students to enable the College to run the course. Should this number not be reached and we are unable to run the course we will offer an alternative or refund any deposit paid. You will be informed if any changes need to be made.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

Degree course – Also referred to as 'course', this term refers to the qualification you will be awarded upon successful completion of your studies. 'Courses' were formerly known as 'programmes' at Royal Holloway.

Module – This refers to the credits you will study each year to complete your degree course. . Postgraduate taught degrees at Royal Holloway comprise 180 credits. On some degree courses a certain number of optional modules must be passed for a particular degree title. 'Modules' were formerly known as 'course units' at Royal Holloway.

# Section 3 - Degree course structure

### 3.1 Mandatory module information

The following table summarises the mandatory modules which students must take in each year of study

This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules. Mandatory modules fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module to successfully graduate with a particular degree title, or before you can proceed to the next year of your course where studying part-time. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them (see <u>Academic Regulations</u> on condonable fails). Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example; where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

### 3.2 Optional modules

In addition to mandatory modules, there will be a number of optional modules available during the course of your degree. The following table lists a selection of optional modules that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can normally access via Moodle.

#### 3.3 Optional module requirements

The MSc course comprises six weighted taught modules (120 credits), up to two supplementary modules, and the MSc dissertation (60 credits). The two supplementary modules appear on your transcript but do not contribute to the final degree classification. You decide towards the end of the second term which modules are to be considered as supplementary. At the discretion of the Course Director, you may attend up to two (supplementary) modules from the third or fourth year of the undergraduate course in Mathematics, for example to fill a gap in your knowledge from undergraduate study. You are encouraged to divide your modules equally between the two terms, or over additional years if you are a part-time student.

### Section 4 - Progressing through each year of your degree course

For further information on the progression and award requirements for your degree, please refer to Royal Holloway's Academic Regulations.

Progression throughout the year/s is monitored through performance in summative or formative coursework assignments. Please note that if you hold a Tier 4 (General) Student Visa and you choose to leave (or are required to leave because of non - progression) or complete early (before the course end date stated on your CAS), then this will be reported to UKVI.

#### Part-time course structure

Part-time Masters students are typically expected to take four modules (80 credits) in their first year and complete the remaining modules and the dissertation in the second year\*\*. Part-time students following the standard 2 year part time model will be encouraged to begin work on their dissertation during the summer between their first and second years.

\*\* part time students are permitted under College regulations to complete their course of study over a period of up to 5 years. Sif you are unable to complete the course within the standard 2 year timeframe you should liaise with the course director to agree a time frame for completion.

To pass the Masters course you must achieve an overall weighted average of at least 50.00%. Failure marks between 40-49% can be condoned in courses which constitute up to a maximum of 40 credits, provided that the overall weighted average is at least 50.00%, but a failure mark (i.e. below 50%) in the dissertation cannot be condoned. A mark of less than 40% in **any** of the courses cannot be condoned.



#### Section 5 - Educational aims of the course

The aims of this course are to:

- provide teaching in mathematics, beyond the level of a first degree, in selected areas of mathematics and their applications;
- provide a suitable mathematical foundation for undertaking research or professional employment;
- provide you with a critical awareness of selected problems in the real world, and the mathematical techniques which are commonly used to solve them;
- give you the opportunity to carry out an independent research investigation in a selected area of mathematics and its applications;
- provide you with a range of transferable skills appropriate to progression to PhD studies or employment, including experience with independent research and managing the writing of a dissertation.

### Section 6 – Course learning outcomes

In general terms, the courses provide opportunities for students to develop and demonstrate the following learning outcomes. (Categories – Knowledge and understanding (K), Skills and other attributes (S), and Transferable skills (\*))

- 1. the methods and principles of one or more selected areas of mathematics and their applications, including algebra, cryptography and coding theory, discrete mathematics, probability theory and statistics (K).
- 2. the role and limitations of mathematics in the solution of problems arising in the real world **(K)**.
- 3. demonstrate a high level of ability in subject-specific skills (S).
- 4. ability to clearly formulate problems and express technical content and conclusions in written form (S);\*
- time management (S);\*

- 6. self-motivation, flexibility and adaptability (S);\*
- 7. computer skills (S);\*
- 8. the ability to critically analyse the strengths and weaknesses of solutions to problems in applications of mathematics (S).
- 9. synthesise information from a number of sources with critical awareness;\*
- 10. evaluate research critically (S);  $^{\star}$
- 11. preparation of an MSc dissertation (S) (MSc only)\*



# Section 7 - Teaching, learning and assessment

Teaching and learning in the course are closely informed by the active research of staff. In general terms, the course provides opportunities for you to develop and demonstrate the learning outcomes:

For the taught modules, teaching is mainly by lectures, supported by weekly written coursework assignments. Learning is augmented by occasional computer projects and independent private study using books, course notes and the internet. For the dissertation, learning is by independent research and private study, supported by research supervision. You receive regular feedback on: your performance on coursework for taught modules; your detailed research proposal (end of examinations term); and dissertation drafts near the completion of the project. Completion of tasks is monitored centrally to ensure students experiencing difficulty can be identified and provided with appropriate support.

Assessment is mainly by examination in May for the taught modules. Some modules may also require extended essays, reports, computer programming or oral examinations. The dissertation is submitted at the end of the summer, approximately two weeks before the beginning of the next academic year. For details of the assessment of the main project see the Course Handbook. Full details of the assessments for individual modules can be obtained from the <u>Department</u>.

#### Section 8 – Additional costs

There are no single associated costs greater than £50 per item on this degree course.
