

# Royal Holloway, University of London Course specification for an undergraduate award BA Film Studies with Philosophy (W6V<sub>5</sub>)

## Section 1 - Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. Your degree course in Film Studies with Philosophy is delivered full-time in three stages, each of which comprises one year of full-time study during which you must follow modules to the value of 120 credits. It is characterised by its progressive structure, which allows for increasing specialisation through the course. A foundational first year provides the basis for increased specialisation in subsequent years, where you are able to develop and pursue your individual intellectual interests.

For joint and combined honours courses, please refer to the course specification for your secondary department's corresponding single honours course for further information on educational aims, and learning outcomes.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

Degree course – May also be referred to as 'degree programme' or simply 'programme', these terms refer to the qualification you will be awarded upon successful completion of your studies.

Module – May also be referred to as 'course', this refers to the individual units you will study each year to complete your degree course. Undergraduate degrees at Royal Holloway comprise a combination of modules in multiples of 15 credits to the value of 120 credits per year. On some degree courses a certain number of optional modules must be passed for a particular degree title.

This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules each year. Mandatory modules fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module before you can proceed to the next year of your course, or to successfully graduate with a particular degree title. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them. Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example; where



requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

\*Contact hours come in various different forms, and may take the form of time spent with a member of staff in a lecture or seminar with other students. Contact hours may also be laboratory or, studio-based sessions, project supervision with a member of staff, or discussion through a virtual learning environment (VLE). These contact hours may be with a lecturer or teaching assistant, but they may also be with a technician, or specialist support staff.

\*\*The way in which each module on your degree course is assessed will also vary, however, the assessments listed above are all 'summative', which means you will receive a mark for it which will count towards your overall mark for the module, and potentially your degree classification, depending on your year of study. On successful completion of the module you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report, dissertation or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular module.

#### 3.2 Optional modules

In addition to mandatory modules, there will be a number of optional modules available during the course of your degree. The following table lists a selection of optional modules that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can access via their webpage.

#### 3.3 Optional module requirements

In stage 2, students must choose 90 credits from the film and television modules offered in the Department of Media Arts and 30 credits in Philosophy. In stage 3, students must choose Media Arts options to the value of 60 credits, plus optional modules in the other subject.

# Section 4 - Progressing through each year of your degree course

For further information on the progression and award requirements for your degree, please refer to Royal Holloway's <u>Academic Regulations</u>.

All first year students on single, joint or combined honours courses offered all or in part by the School of Humanities, School of Performing and Digital Arts, or department of Politics, International Relations and Philosophy are required to pass a Moodle-based writing skills quiz in order to progress into the second year of study. The pass mark for the test is 60%. Certificates of Distinction are awarded to students who achieve at least 80% in the quiz. Students may attempt the quiz as often as they wish with no penalties or capping. Students who meet the requirements for progression as stipulated in the College's Undergraduate Regulations (Section: Conditions for progression to the next stage) but fail to pass the Moodle-based quiz will not be permitted to progress into their second year of academic study at the College.



## Section 5 – Educational aims of the course

The aims of this course are:

- foster intellectual enquiry into the functions and operations of film, television, video and digital media arts, meeting the general requirements of the subject benchmarking statement in the development of knowledge, understanding, and discipline-specific key skills;
- provide a flexible and progressive structure in which students are able to gain knowledge and understanding of film and television studies;
- offer modules in which teaching is informed by research activity and professional expertise;
- produce graduates who can confidently apply conceptual skills, whether in the communication industries or in the wider world of work or further learning, to contribute to the national and international community.



## Section 6 - Course learning outcomes

In general terms, the courses provide opportunities for students to develop and demonstrate the following learning outcomes. (Categories – Knowledge and understanding (K), Skills and other attributes (S), and Transferable skills (\*))

- Understanding and application of theories of meaning and communication in audiovisual media (K);
- 2. Knowledge of selected cinema, television and media art traditions in Europe and North America (K);
- 3. Understanding of the role and significance of audio-visual media in contemporary society **(K)**;
- 4. Understanding forms of communication, media and culture as they have developed historically, with reference to social, cultural and technological change (K);
- 5. Develop substantive and detailed knowledge and understanding in selected areas of the field **(K)**;
- 6. Competence in the interpretation of audio-visual texts (S);
- 7. Competence in independent thinking informed by appropriate critical theories of media and culture (for example, gender studies, psychoanalytic theory, cultural studies and postmodernism) (5);
- 8. Ability to make informed contributions to debates about communication and public life (S);
- 9. Ability to engage critically with major thinkers, debates and intellectual paradigms within the field and put them to productive use (S);
- 10. Ability to examine media forms critically with appropriate reference to social and cultural contexts and the diversity of contemporary society (S);
- 11. Ability to consider and evaluate own work in a reflective manner, with reference to academic and/or professional issues, debates and conventions (S);
- 12. Ability to carry out analysis, problem-solving, and decision-making, and to abstract and synthesise information (S\*);

- 13. The ability to develop a reasoned argument and to articulate these through written and oral communication (5\*);
- 14. Learn and study, take responsibility for own learning, and develop habits of reflection on that learning (S\*);
- 15. Information technology (including word processing, email and WWW) and development of specific proficiencies in utilising selected media technologies (S\*);
- 16. Information handling and retrieval: identifying, retrieving, synthesising and presenting information, investigating a wide range of sources (S\*);
- 17. Interpersonal skills including listening, leadership, responding to others appropriately and contributing to a team (S\*);
- 18. In addition, the course fosters the development of a range of personal attributes that are important in the world of work, and that strengthen our graduates' abilities to engage in lifelong learning and contribute to the wider community. These include: personal motivation; the ability to work autonomously and with others; creativity; self-awareness and self-management; empathy and insight; intellectual integrity; awareness of responsibility as a local, national and international citizen; interest in lifelong learning; flexibility and adaptability (S).



## Section 7 - Teaching, learning and assessment

Teaching and learning is mostly by means of lectures, seminars, small-group tutorials, guided independent research, and guided independent study. Assessment is by formal examinations, coursework essays and other exercises, oral presentations and through the independent dissertation or research project.
