### Course specification for an undergraduate award

#### BA Drama with Acting (W4W7)

##### Section 1 – Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. Your degree course in Drama with Acting is delivered in three stages, each of which normally comprises one year of full-time study, during which you must follow modules to the value of 120 credits.

In your **first year**, you will study the 30-credit module DT1500 The Expressive Actor, which provides an experiential foundation in practical voice, speech and body skills primarily targeted at the actor and the application of these to the oral interpretation of a range of written texts. You will also take two foundational 30-credit modules in Drama, Theatre and Dance, including DT1100 Theatre and Performance Making 1, DT1200 Theatre and Text 1, and two 15-credit modules, DT1400 Theatre and Idea 1 and DT 1600 Skills Lab. These modules introduce you to practical and theoretical aspects of Drama and Theatre studies and will introduce you to forms of performance from around the world.

In the **second year** you will take the mandatory module, DT2108 Stage Acting, where you will develop an appreciation of stage acting techniques that will enable you to perform play texts from the 16th-21st centuries. You will have the opportunity to work as actors for the MA Directing students in the Drama, Theatre and Dance Department. You may choose to study optional Drama, Theatre and Dance modules related to acting and movement, such as DT2402 The Idea of Acting and DT2418 The Idea of Movement, as well as second year modules on topics ranging from Greek tragedy to feminist performance to dramaturgy.

In your **third year**, you will deepen your practical skills and experience by working with emerging theatre directors, as well advance your knowledge of specialisms at the cutting edge of our discipline. The final year contains one mandatory module, DT3205 Advanced Acting (30 credits), where you will be offered an experiential deepening of the practical vocal and bodily skills developed during years one and two of your degree. As part of this module, you will collaborate with one of the Drama Department's MA Directors over Spring and Summer terms, through which process you will work as a performer on an MA final performance work in the Summer Term. You will also select 60 credits of modules according to your interest from the Drama Department's Advanced Option Workshop and Seminar options; options may include Workshop modules such as Acting 360, The Actor's Voice or Design, or Research options such as Naturalist Theatre or Performance and Visual Art. In spring term, you will collaborate on a student-led Group Performance project (30 credits), which will be driven by student interest and supervised by a member of staff in Drama, Theatre and Dance.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is a brief description for some of the most important terminology for understanding the content of this document:

*Degree course* – May also be referred to as ‘degree programme’ or simply ‘programme’, these terms refer to the qualification you will be awarded upon successful completion of your studies.

*Module* – May also be referred to as ‘course’, this refers to the individual units you will study each year to complete your degree course. Undergraduate degrees at Royal Holloway comprise a combination of modules in multiples of 15 credits to the value of 120 credits per year. On some degree courses a certain number of optional modules must be passed for a particular degree title.

<p>This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules each year. Mandatory modules fall into two categories: 'condonable' or 'non-condonable'.</p> <p>In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module before you can proceed to the next year of your course, or to successfully graduate with a particular degree title. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them. Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example: where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.</p>					
3.2 Optional modules					
<p>In addition to mandatory modules, there will be a number of optional modules available during the course of your degree. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example where reasonable and necessary due to unexpected events, where requirements of relevant Professional,</p>					

Statutory or Regulatory Bodies (PSRBs) have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection; please contact the Department for further information.

**Section 4 - Progressing through each year of your degree course**

Progression throughout the year/s is monitored through performance in summative or formative coursework assignments. Please note that if you hold a Student Visa and you choose to leave (or are required to leave because of non-progression) or complete early (before the course end date stated on your CAS), then this will be reported to UKVI.

All first year students on single, joint or combined honours courses offered all or in part by the School of Humanities, School of Performing and Digital Arts, or department of Politics, International Relations and Philosophy are required to pass a Moodle-based writing skills quiz in order to progress into the second year of study. The pass mark for the test is 60%. Certificates of Distinction are awarded to students who achieve at least 80% in the quiz. Students may attempt the quiz as often as they wish with no penalties or capping. Students who meet the requirements for progression as stipulated in the [College's Undergraduate Regulations](#) (Section: Conditions for progression to the next stage) but fail to pass the Moodle-based quiz will not be permitted to progress into their second year of academic study at the College.

## Section 5 – Educational aims of the course

The aims of this course are:

1. To take sensitive, imaginative, and creative approaches to the vocal and physical interpretation of a range of performance texts or scores and to reflect effectively on your own and others' performance
2. To exercise independence in the development of 'embodied knowledge' and 'practice as research' through performance and training
3. To develop a synthesised and contextualised understanding of the elements of performance training and practice for a range of performance contexts which may include site specific, immersive, digital immersive and verbal theatres, in addition to theatrical stage performance
4. To develop an informed awareness of vocal anatomy and vocal production
5. To design and implement activities and outcomes for the development of acting skills relevant to a practice selected and researched by you.
6. To engage as an actor in a performance process with an MA Director, demonstrating professionalism, ability to research independently, to work flexibly and to reflect on your process.
7. To develop an awareness of a range of performance training pedagogies, with particular focus on how critical acting methods can bring greater awareness of histories of institutional inequality which are present within theatre and performance.
8. To take personal responsibility for development of training and expressive performance practice

## Section 7 - Teaching, learning and assessment

Teaching and learning on your course is closely informed by the active research of staff, particularly in the areas of vocal training, stage techniques, Asian acting traditions, site-specific performance, screen studies. In general terms, the course provides an opportunity for you to develop and demonstrate the learning outcomes detailed herein.

Teaching and learning is mostly by means of workshops; performances; lectures; seminars; study groups; essay consultations; oral presentations and guided independent study. Assessment of knowledge and understanding is typically by performances, portfolios, essays, and oral presentations. A breakdown of assessment types for individual modules is shown in section 3.

Contact hours come in various forms and may take the form of time spent with a member of staff in a lecture or seminar with other students. Contact hours may also be laboratory or, studio-based sessions, project supervision with a member of staff, or discussion through a virtual learning environment (VLE). These contact hours may be with a lecturer or teaching assistant, but they may also be with a technician, or specialist support staff.

The way in which each module on your degree course is assessed will also vary, however, for the assessments listed as 'summative', you will receive a mark for it which will count towards your overall mark for the module, and potentially your degree classification, depending on your year of study. On successful completion of the module you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report, dissertation or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular module
