

# Royal Holloway, University of London Course specification for a postgraduate award MRes Classical Reception (3091)

Section 1 – Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. The course is delivered over one year of full-time study (52 weeks) or two years of part-time study (104 weeks). On successful completion of the course you should have an understanding of the area of the MA at a level appropriate for a postgraduate qualification. Whilst being a self-contained degree in its own right, the course provides suitable and recognised qualifications for entry to PhD study in the same or a closely related field.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

Degree course – Also referred to as 'course', this term refers to the qualification you will be awarded upon successful completion of your studies. 'Courses' were formerly known as 'programmes' at Royal Holloway.

*Module* – This refers to the credits you will study each year to complete your degree course. Postgraduate taught degrees at Royal Holloway comprise 180 credits. On some degree courses a certain number of optional modules must be passed for a particular degree title. 'Modules' were formerly known as 'course units' at Royal Holloway.

Progression throughout the year/s is monitored through performance in summative or formative coursework assignments. Please note that if you hold a Tier 4 (General) Student Visa and you choose to leave (or are required to leave because of non-progression) or complete early (before the course end date stated on your CAS), then this will be reported to UKVI.

The aims of this course are to:

- Encourage you to develop your research skills;
- Introduce you to reception theory, specifically in relation to literary and political thought;
- Develop advanced skills in the presentation of research;
- Provide you with the skills and background necessary for further study;
- Provide you with key research skills, the ability to work independently and in a self-directed fashion; to devise and deliver a research project; and an ability to set research goals.

# Section 7 - Teaching, learning and assessment

Teaching and learning is mostly by means of seminar discussions and oral presentations, guided independent research, guided independent study, coursework essays, and a dissertation. The basic strategies are to nurture your interest and enthusiasm for the field, to develop the your critical and communication skills and to develop critical, research and creative skills. Assessment of knowledge and understanding is typically through written work. Formative feedback will be provided continuously and through a number of reports in term one (as specified in the particular modules), the longer project in draft in term two (from the supervisor of the project), and through discussion of the research dissertation, especially in terms two and three (with the project supervisor). Details of the assessments for individual modules can be obtained from the <u>Department</u>.
