

# Royal Holloway, University of London Course specification for a postgraduate award MSc MICROWAVE AND OPTICAL FIBRE COMMUNICATIONS (3723)

#### Section 1 – Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Your degree course in Microwave and Optical Fibre Communications provides progressive structures in which you will be able to gain ever-wider knowledge and understanding, and appropriate skills. Microwave and optical fibre communication systems enable high-speed communication, enabling our everyday life to be conceivable: high-speed home-based internet, smart mobile phones, machine-to-machine communication systems, and 'Everything Connected'. You will be working with skills and resources that provide hands-on experience in this area.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

Degree course – Also referred to as 'programme', this term refers to the qualification you will be awarded upon successful completion of your studies. 'Courses' were formerly known as 'programmes' at Royal Holloway.

Module – This refers to the credits you will study each year to complete your degree course. Postgraduate taught degrees at Royal Holloway comprise 180 credits. On some degree courses a certain number of optional modules must be passed for a particular degree title. 'Modules' were formerly known as 'course units' at Royal Holloway.

This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules each year. Mandatory modules fall into two categories: 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module before you can proceed to the next year of your course, or to successfully graduate with a particular degree title. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them. Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example: where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.

All postgraduate taught students are required to take and pass the non-credit bearing Moodle-based Academic Integrity module SS1001 in order to be awarded. The pass mark for the module assessment is stated in the on-line Academic Integrity Moodle module. Students may attempt the assessment as often as they wish with no penalties or capping. Students who otherwise meet the requirements for award as stipulated in the College's Postgraduate Taught Regulations (Section 15: Consideration and classification of candidates for the award) but fail to pass the Moodle-based Academic Integrity module will not be awarded.

# Section 5 - Educational aims of the course

The aims of this course are to:

- 1. Provide students with the capacity of using advanced broadband communications to enable high-speed communication between multiple users at the same time: high-speed home-based internet, smart mobile phones, machine-to-machine communication systems, 'Everything Connected', 5G/6G and beyond.
- 2. Equip students with a deep understanding of Radio over Fibre (RoF) components and systems for the transmission of microwave signals.
- 3. Expose the students to hands-on experience with fibre optic, RoF, and microwave devices and systems.
- 4. Expose students to the latest cutting-edge research and up-to-date curriculum in the discipline and related topics.
- 5. Engage the students in extensive teamwork in state-of-the-art laboratories, promoting an environment for creativity, invention, and product development.
- 6. Expose students to examples of good practice in the discipline.
- 7. Expose students to real-world, current, and cutting-edge projects and research.
- 8. Enhance students' employability by the involvement of external industry partners, in the form of guest lectures and seminars, student sponsorship, potential internships and the proposal of project topics.



## Section 6 - Course learning outcomes

In general terms, the courses provide opportunities for students to develop and demonstrate the following learning outcomes. (Categories – Knowledge and understanding (K), Skills and other attributes (S), and Transferable skills (\*))

- 1. Ability to analyse and formulate a wide range of communication problems using microwave and photonic components, as well as their integration into broadband transmission systems (K, S).
- 2. Ability to analyse, design, implement and test fibre optics and Radio over Fibre (RoF) communications engineering projects (K, S).
- 3. Critical understanding of a wide range of advanced theories, simulation methods, and practical design spectral efficiency techniques applied in the industry (K, S).
- 4. Critical understanding of the context in which communications engineering projects are practiced, as well as their effect on society (K, \*).
- 5. Acquiring analysis, problem-solving, and decision-making skills in the context of engineering projects (S, \*).

- 6. Experience working in small teams to deliver presentations and collaborate on engineering projects (S, \*).
- 7. Ability to work independently on a major engineering project, potentially involving student-led prototyping and/or industrial collaboration (K, S, \*).
- 8. Development of key transferable skills, including academic writing and oral presentations, computer programming, and project management (S, \*).
- 9. Acquiring an independent learning ability required for continuing professional development (\*).



#### Section 7 - Teaching, learning and assessment

Teaching and learning on your course is closely informed by the active research of staff in fibre optics and Radio over Fibre (RoF) communications, and their application to emerging smart communication technologies in 5G/6G and beyond, as well as in areas such as space and defence. In general terms, the course provides an opportunity for you to develop and demonstrate the learning outcomes detailed herein.

Teaching follows several different complementary models: face-to-face, online, pre-recorded, workshops, presentations, practical sessions, labs. Assessments cover a variety of activities: groupwork, presentations, reports, Moodle quizzes, etc. Across the course, examples and case-studies are international and cover many different backgrounds. Modules feature built-in formative assessments (e.g. Moodle quizzes, workshops, presentations) that complement and lead up to summative assessment. Students have a close relationship with their tutors, and with the teaching staff in general, which means they have many opportunities for feedback. They receive oral feedback in workshops, presentations, practical sessions, and labs.

Contact hours come in various forms and may take the form of time spent with a member of staff in a lecture or seminar with other students. Contact hours may also be laboratory or, studio-based sessions, project supervision with a member of staff, or discussion through a virtual learning environment (VLE). These contact hours may be with a lecturer or teaching assistant, but they may also be with a technician, or specialist support staff.

The way in which each module on your degree course is assessed will also vary, however, for the assessments listed as 'summative', you will receive a mark for it which will count towards your overall mark for the module, and potentially your degree classification, depending on your year of study. On successful completion of the module you will gain the credits listed. 'Coursework' might typically include a written assignment, like an essay. Coursework might also include a report, dissertation or portfolio. 'Practical assessments' might include an oral assessment or presentation, or a demonstration of practical skills required for the particular module
