

# Royal Holloway, University of London Course specification for a postgraduate award MA Politics of Development (3105)

Section 1 – Introduction to your course

This course specification is a formal document, which provides a summary of the main features of your course and the learning outcomes that you might reasonably be expected to achieve and demonstrate if you take full advantage of the learning opportunities that are provided. Further information is contained in the College prospectus, and in various handbooks, all of which you will be able to access online. The course is delivered over one year of full-time study (52 weeks) or up to five years of part-time study (260 weeks). Teaching takes place during the day over two terms from September to April. The dissertation is submitted in September. Whilst being a self-contained degree in its own right, each course provides suitable and recognised qualifications for entry to PhD study in the same or a closely related field.

While Royal Holloway keeps all the information made available under review, courses and the availability of individual modules, especially optional modules are necessarily subject to change at any time, and you are therefore advised to seek confirmation of any factors which might affect your decision to follow a specific course. In turn, Royal Holloway will inform you as soon as is practicable of any significant changes which might affect your studies.

The following is brief description for some of the most important terminology for understanding the content of this document:

Degree course – Also referred to as 'course', this term refers to the qualification you will be awarded upon successful completion of your studies. 'Courses' were formerly known as 'programmes' at Royal Holloway.

*Module* – This refers to the credits you will study each year to complete your degree course. Postgraduate taught degrees at Royal Holloway comprise 180 credits. On some degree courses a certain number of optional modules must be passed for a particular degree title. 'Modules' were formerly known as 'course units' at Royal Holloway.

This table sets out the most important information for the mandatory modules on your degree course. These modules are central to achieving your learning outcomes, so they are compulsory, and all students on your degree course will be required to take them. You will be automatically registered for these modules. Mandatory modules fall into two categories; 'condonable' or 'non-condonable'.

In the case of mandatory 'non-condonable' (MNC) modules, you must pass the module to successfully graduate with a particular degree title, or before you can proceed to the next year of your course where studying part-time. In the case of mandatory 'condonable' (MC) modules, these must be taken but you can still progress or graduate even if you do not pass them (see <u>Academic Regulations</u> on condonable fails). Please note that although Royal Holloway will keep changes to a minimum, changes to your degree course may be made where reasonable and necessary due to unexpected events. For example; where requirements of relevant Professional, Statutory or Regulatory Bodies have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of external advisors, to enhance academic provision.



# 3.2 Optional modules

In addition to mandatory modules, there will be a number of optional modules available during the course of your degree. The following table lists a selection of optional modules that are likely to be available. However, not all may be available every year. Although Royal Holloway will keep changes to a minimum, new options may be offered or existing ones may be withdrawn. For example; where reasonable and necessary due to unexpected events, where requirements of relevant Professional, Statutory or Regulatory Bodies (PSRBs) have changed and course requirements must change accordingly, or where changes are deemed necessary on the basis of student feedback and/or the advice of External Advisors, to enhance academic provision. There may be additional requirements around option selection, so it is important that this specification is read alongside your department's Student Handbook, which you can normally access via Moodle.

Section 4 - Progressing through each year of your degree course

Please note: all postgraduate taught students are required to take and pass the non-credit bearing Moodle-based Academic Integrity module SS1001 to be awarded. The pass mark for the module assessment is stated in the on-line Academic Integrity Moodle module. Students may attempt the assessment as often as they wish with no penalties or capping. Students who otherwise meet the requirements for award as stipulated in the College's <u>Postgraduate Taught Regulations</u> (Section 15: Consideration and classification of candidates for the award) but fail to pass the Moodle-based Academic Integrity module will not be awarded.

Progression throughout the year/s is monitored through performance in summative or formative coursework assignments. Please note that if you hold a Tier 4 (General) Student Visa and you choose to leave (or are required to leave because of non - progression) or complete early (before the course end date stated on your CAS), then this will be reported to UKVI.

#### Part-time course structure

The part-time course normally lasts two years (104 weeks), beginning in September of year one. Part-time students normally complete their mandatory modules (except dissertation) and one option in the first year and take their remaining option modules in the second year, submitting their dissertation at the end of the second year.



#### Section 5 – Educational aims of the course

The aims of this course are to:

- to provide a systematic understanding and knowledge of theories, institutions, and practices in the disciplines of politics and international relations as they relate to the study of development in Africa, Asia and the Middle East;
- to encourage a critical awareness of current problems and developments in political science and international relations generally and in the specific sub-disciplines related to development and politics in the Third World;
- to provide theoretical insights and methodological techniques relevant to the creation and interpretation of knowledge in politics and international relations and to the critical evaluation of current research and advanced scholarship;
- to provide training in research techniques;
- to foster an independent learning ability required for continuing professional development and/or further academic research;
- to develop key communications, IT and management skills relevant for postgraduate work.



#### Section 6 – Course learning outcomes

In general terms, the courses provide opportunities for students to develop and demonstrate the following learning outcomes. (*Categories – Knowledge and understanding (K*), Skills and other attributes (S), and Transferable skills (\*))

- 1. An advanced knowledge and critical understanding of key concepts, theoretical debates, and developments in the fields of politics and international development **(K)**;
- 2. A sound knowledge of the texts, theories and methods used to enhance understanding of the issues, processes and phenomena associated with the fields of politics and international development (K);
- 3. An advanced knowledge and critical understanding of research methods within the disciplines of politics and international development **(K)**;
- 4. Knowledge of advanced scholarship in the chosen area of the discipline to a level appropriate for a Masters degree (K);
- 5. The ability to evaluate relevant critical, theoretical and contextual research at the forefront of the field **(S)**;
- The ability to articulate knowledge and the understanding of texts, concepts and theories at an advanced level, demonstrating self-direction and originality (S);
- The ability to assess the nature and value of a wide variety of source materials

   including, where appropriate, academic commentaries, research-based literature, official publications and statistics, journalistic sources, political biographies and make effective use of such materials (S);
- 8. The ability to develop their own lines of criticism and argument (S\*);

- 9. The ability to conduct research independently at an advanced level using traditional and electronic resources (S\*);
- 10. The ability to assess the merits of contrasting theories, explanations and policies (S\*);
- 11. The ability to develop reasoned and balanced arguments (S\*);
- 12. The ability to manipulate precise and intricate ideas, construct logical arguments and use technical terminology correctly **(S\*)**;
- 13. The ability to deal with complex issues, both systematically and creatively, and make sound judgments (S\*);
- 14. The ability to identify, investigate, analyse, formulate and advocate solutions to problems (S\*);
- 15. The ability to communicate complex information and ideas effectively, both orally and in writing **(S\*)**;
- 16. The ability to write up a substantial dissertation project, using the appropriate methodological and bibliographical skills **(S\*)**.



# Section 7 - Teaching, learning and assessment

Teaching and learning is delivered primarily by means of seminar discussions, informal lectures, oral presentations, guided independent research, and guided independent study. Assessment takes the form of various formative and summative assignments, all in the form of coursework submitted during the course. There are no exams. The final assignment for the course is a dissertation on a topic developed in consultation with an assigned supervisor. It is expected that the dissertation will be researched and written primarily in the summer months, although supervision and dissertation training will begin during the academic year. Full details of assessments, including submission schedules and marking criteria, can be found in the Course Handbook. Teaching and learning methods and specific assignments for each module are written into the various module outlines. Full details of individual modules can be obtained from the <u>Department</u>.
