## Outcomes of past funded projects

The KOL group has been successful in using seedcorn funding to encourage and support cross-disciplinary research and public/practitioner engagement activities. Some recent examples include:

- Neil Conway's KOL-funded project (2014) on 'the calling of Church of England clergy' has led to a clergy practitioner impact case study, and his inclusion in a grant application being prepared by Olivia Swift about the calling and wellbeing of seafarers, involving other investigators from the School of Law.
- Gillian Symon and Yingqin Zheng received KOL pilot project funds (2015) for an interdisciplinary project (OS/HRM and TIM) examining smart phone use by migrant workers in Shanghai. Outputs from this work have so far been presented at an IS conference and an organizational psychology conference.
- A practitioner engagement workshop, entitled 'Social Media for Emergency Management: Innovation at difficult time' was sponsored by the KOL group and held in collaboration with the SM4EM Project coordinated by Amany Elbanna (Senate House, London, July 2015).
- A user engagement workshop, entitled 'Patient and Public Involvement (PPI) on telehealth research' was sponsored by the KOL group and coordinated by Roberta Bernadi. (Senate House, London June 2016).
- Btissam Aboubichr, a PhD member, received funds to support her research on social learning and performance management, which led to applying for a 3-month research scholarship in the Faculty of Psychology, University of Calgary.
